NARRATIVE

About 2:00 AM on Sunday, 9/11/22, Officers Walsh and Askins in the B101A, conducted a traffic stop resulting in the arrest of Henry Barboza for firearm related offenses, at the intersection of Warren Street and Carlisle Street, Roxbury.

Officers were operating marked Boston Police cruiser #1509, equipped with visible emergency lights and full Boston Police decals. Officer Askins was driving and Officer Walsh was sitting in the passenger seat, both officers were wearing full Boston Police uniforms, with uniform patches on both shoulders and badges displayed on their outermost garments.

Officers were situated at the red light in the outbound lane of Blue Hill Avenue at the intersection of Warren Street when they observed a gray Nissan Altima travel from Blue Hill Avenue inbound, onto Warren Street. Officers attention

was drawn to this vehicle as its exhaust was louder than usual, and the vehicle was not affixed with a front registration plate (90:6) and lacked a driver's side mirror (90:7). As the vehicle passed officers additionally observed that the vehicle had aftermarket window tints haphazardly placed on the rear passenger windows (90:9D).

It should be noted that due to the time of night and positioning of the window tint officers were unable to determine the race or gender of the occupant(s), and initially were unable to determine the number of occupants.

Officers then positioned their cruiser behind the vehicle as it traveled on Warren Street and conducted a query of the vehicle's rear registration plate, bearing MA Reg [REDACTED]. The CJIS query returned that the vehicle's registration had been REVOKED for a lack of insurance on 11/04/21 (90:34). Based on the aforementioned violations officers made the decision to conduct a traffic stop. Officers activated their emergency lights and siren at the intersection of Warren Street and Gaston Street. Officers noted that the vehicle did not immediately pull over to the right and stop, but continued driving for a short distance past several open locations on the side of the roadway. Additionally, now that officers were positioned directly behind the vehicle, and the rear windshield was free of any aftermarket tint or obstructions, they noted that the vehicle was occupied solely by the driver, who had a hood pulled over their head. Officers observed the driver's right shoulder dip down and lean to the right, as if the operator was concealing or retrieving an item from the passenger side of the vehicle. Officers then observed the driver return to an upright position then bring the vehicle to a stop on Warren Street just before Carlisle Street.

As Officers approached the vehicle the driver, later identified as Henry Barboza, immediately placed both of his hands outside of the driver's window and leaned his head towards Officer Askins, who was approaching on the driver's side. Both of Barboza's hands were visibly shaking, and the driver immediately stated that he had no license or registration and that he was out on bail. Due to Barboza's demeanor, coupled with the physical action, leaning to the passenger side floor of the vehicle, officers feared that Barboza may be in possession of a weapon, and he was removed from the vehicle and frisked for weapons to negative results. Officer Askins then asked Barboza what he had reached across the vehicle for to which he responded that he was on the phone with his sister, although Officer Askins observed his phone to be on the driver's seat where he had been sitting. Due to these inconsistent statements, based on their observations, officers feared that Barboza may have discarded a weapon within reaching distance, in the passenger compartment of the vehicle. Officer Askins then began to frisk the vehicle. Upon checking behind the passenger seat Officer Askins observed what he knew to be a firearm on the floorboard of the vehicle. Barboza was immediately placed into handcuffs, and Officer Askins demanded his license to carry a firearm to which Barboza responded "I don't have one, sir." Barboza was then placed into the back of marked Boston Police cruiser #1509 where he was read Miranda warning by Officer Askins from a Miranda card provided by Officer Centeio which he keeps on his person. Barboza was then transported back to District B-2 by the B103A (O'Leary/Cam Williamson) where he was booked without incident.

District B-2 Patrol Supervisor, Sgt. Dervan (B913) responded, along with B-2 detectives, Det. Kennedy (B803) and Det. Gamble (B832) responded and recovered and photographed the firearm.

Always Open towing responded and removed the unregistered vehicle from the roadway. (Tow Slip #31050) Tow line notified (Johnson) Form 2012 completed.

The firearm was determined to be a .32 Cal Smith & Wesson Long OTGZ revolver, loaded with 5 rounds of ammunition with one empty chamber, serial [REDACTED]. The firearm was reported stolen [REDACTED].
