### NARRATIVE

Original Narrative:  
 Created: 06/29/2014 21:18:50 By: CROSSEN, ZACHARY (131216)  
 At about 6:04PM on Sunday, June 29, 2014, Officers Crossen and Ward in the B104F responded to a radio call for a person shot in the street in front of 15 Ruggles Street, Roxbury.  
 Upon arrival, the officers approached the victim [REDACTED], who was suffering from gunshot wounds to the abdomen. Officer Crossen was able to obtain the victim's identity and brief description of the suspects from the victim. The Officers observed ballistic evidence (3 spent shell casings) in close proximity to the victim. Victim was transported to BMC by EMS P2.  
 The officers were able to locate Witness #1 (Known to Commonwealth) who stated he had seen the shooting from a close range. [REDACTED]

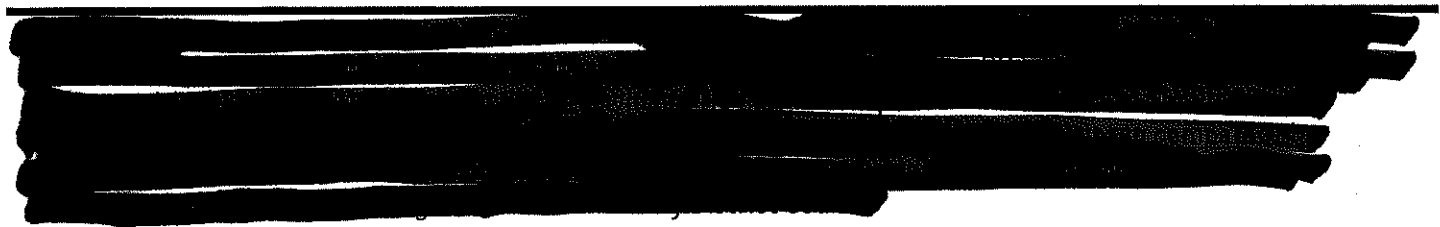
