NARRATIVE

At approximately 10:31 AM, Saturday, 08/13/2022, members of the E-13 Drug Control Unit, along with members from the A-1 Drug Control Unit, under the direct supervision of Sergeant Detective Brian Evans executed West Roxbury District Court issued Search Warrant (2206SW0071) for the body of Miguel E. Chalas Garcia, in furtherance of "Operation Spring Clean Up."

Officers were able to make peaceful entry into [REDACTED] and announce their office and purpose. Chalas Garcia was secured by officers. Officer Santiago using a Spanish Miranda Warning card advised Chalas Garcia of his Miranda Warnings, to which he acknowledged he understood.

Officer seized \$900 in US Currency from Chalas Garcia. Nothing else of evidentiary value was seized.

Seized money form completed. Seized money deposited into the Boston Police Headquarters financial evidence safe.
