NARRATIVE

About 01:15am on Wednesday, 09/14/2022, Officers Schmitz and Grande in the F102A while on a fixed code 19 at Southampton Street, on-sited shots fired which resulted in the confiscation of a firearm and arrest of two suspects.

While on the code 19, officers attention were drawn to the immediate area across from 115 Southampton St (BFD Headquarters) due to the sound of one (1) gunshot and a crowd of people running away from the area. Officers observed the crowd of people running away, yelling and screaming as if they were in fear for their safety. Officers along with the FG02A (Hanton) drove up to the area of the gunshot and observed 3 black males engaged in a physical altercation. As Officer Hanton was getting out of his marked Boston Police cruiser, he heard the sound of a metal metallic object hitting the pavement and subsequently observed a firearm on the ground in the vicinity of the three males. Officer Hanton along with Officer Schmitz drew their department issued firearms and ordered the three males to stop fighting and to get on the ground. The three males immediately dispersed and all went their separate ways. Officers were able to stop and detain two black males later identified as Eddie WALKER (DOB: [REDACTED]) and Torre

JENKINS (DOB: [REDACTED]) who were engaged in the physical altercation. At this time it is unclear to officers which one of the three males possessed the firearm. It should also be noted none of the multiple witnesses on scene were able to tell officers who was in possession of the firearm.

Officers before questioning WALKER, was mirandized by Officer Grande using a Boston Police Miranda Right's Card to which WALKER acknowledged that he understood his rights. [REDACTED]

Officers then spoke to JENKINS who stated [REDACTED] When asked if JENKINS [REDACTED]

While on scene, officers canvassed the area for further weapons to which two ID's were located inside the blue canvas enclosure where the fight and shooting occurred. The first ID belonged to [REDACTED] (DOB: [REDACTED]) should be noted that [REDACTED] was [REDACTED] [REDACTED] was uncooperative with officers and denied seeing anything occur at the scene. [REDACTED] was frisked for any weapons/drug paraphernalia to no avail. The second ID recovered at the scene belonged to [REDACTED] (DOB: [REDACTED]) but it is unclear if [REDACTED] has any involvement in the incident. The TE517 (Warren) responded to the scene to locate any further weapons or ballistics to no avail.

Due to the nature of the Southampton Street area and transient population, the firearm was recovered by the HA02 (Lt. Smith) and secured in a department vehicle while the scene was made safe. The firearm was photographed at District C-6 by the F915 (Sgt. Albanese). The F983 (Sgt Det Dineen) was also notified of the incident.

The firearm recovered was a Model 1911A1 US Army from Auto Ordinance Corps (Serial# [REDACTED]) with the slide jammed and 1 spent .45 Caliber shell casing recovered inside the ejection port that had not been ejected. An additional 5 live .45 Caliber rounds were loaded within the magazine, one of which was a hollow point round.

Both WALKER and JENKINS were placed under arrest and transported to District D-4 for booking. During the search incident to arrest on WALKER, one small white p/b of a substance consistent with crack cocaine was located in WALKER's pocket. The drugs were seized and logged into the Drug Control Log Book #06-0003 Page 109.

WALKER is being charged with:

- **MGL Chapter 94C/32A** : Class B controlled substances; unlawful manufacture, distribution, dispensing or possession with intent to manufacture, etc
- **MGL Chapter 275/14**: Affray, threats or disturbance of peace in presence of justice; recognizance to keep peace

JENKINS is being charged with:
