**NARRATIVE**

About 2:20am on Saturday, 1/7/23 Officers MacDonald, Picarello, Bent, and McCabe in the BK02A and Officers Dunn and McBrien in the BK01A, did make an on-site firearm arrest at 962 Parker St, Jamaica Plain.

As a part of an ongoing threats investigation being conducted by District 3 detectives, the BK02A was directed by Sgt Detective Burrows to the area of 277 Centre Street to assure the safety of the victim (known to the Commonwealth). While conducting this directed patrol, Officers Bent and Picarello proceeded on foot through the Bromley Heath Apartment complex area from Centre St while Officers McCabe and MacDonald proceeded around the building to the rear parking lot in unmarked Boston Police Cruiser #9539. Officers attention was drawn to a black BMW (MA Registration # [REDACTED]) with excessive tint playing music at an excessive volume for the time of night. Officers McCabe and MacDonald exited the cruiser in plain clothes with ballistic vests with Boston Police Marking and badges displayed on the outermost layer.

Upon approach Officer MacDonald proceeded to the driver's side window where he encountered Dominique Finch (DOB 6/21/89) who was in the driver's seat of the vehicle and began asking Officer MacDonald why he needed to identify himself if he was just hanging out. During this encounter Officer McCabe was approaching the passenger side vehicle where through windshield observed the passenger to be giving him a wide-eyed stare. Officer McCabe then witnessed the passenger later identified as Randy Pizarro open the passenger side door, place something underneath the vehicle and immediately close the door shut. Officer McCabe heard the object hit the ground and immediately recognized the sound as a metallic object hitting the ground. Based on his training and experience Officer McCabe believe the object he heard hit the ground to be a firearm. Officer McCabe immediately notified Officer MacDonald that the suspect tossed "one" under the car and he moved the police car in front of the BMW to prevent escape while alerting Officers Bent and Picarello over the radio to proceed faster to their location.

Having been alerted by Officer McCabe to the presence of a firearm Officer MacDonald proceeded to the passenger side of the vehicle removed Pizarro and placed him directly into handcuffs. Officers Bent and Picarello had arrived almost simultaneously to this act and removed Finch from the vehicle also placing him into handcuffs.

Once both suspects were secured in handcuffs and separated Officer MacDonald demanded Pizarro's License to Carry a firearm. Officer Picarello demanded Finch's license to carry a firearm. Both parties denied having a license to carry a firearm. Officer McCabe then read Finch his Miranda Warning from his department issued Miranda Card. Officer Picarello then proceeded to Pizarro and read him his Miranda Warning from the same department issued Miranda Card.

Pizarro was then informed that he was under arrest. During the search incident to arrest Officer Bent discovered 25 bags of a white rock like substance believed to be crack cocaine, along with \$1298 in U.S. currency.

Several Officers arrived on scene to assist including the B201A (Kimayo, Polanco), B454A (O'Leary), B101A (Kadey, Centeio), B103A (Murphy, Reynolds), and Zukowski (B433A). The B201A transported Pizarro back to District B2 for booking without incident.

District 2 Detectives Coakley (B807), Conley (B816), and Sgt Det. DeVito (B982) arrived on scene to process, photograph, and recover the firearm. Once finished Finch was released from the scene.

Detective Coakley identified the firearm as a micro Desert Eagle 380 Auto (Serial #ME09159), with 1 Round of Ammunition in the Chamber, and five rounds of ammunition in the magazine. It should be noted that two of the rounds were hollow point ammunition.

The rock like substance believed to be crack cocaine was packaged in 25 individual bags weighing a total of 6 grams. This evidence was counted and logged into evidence by Officer Picarello. It was entered in the District B2 Drug book 02-004 page 110. Was placed into the District B2 drug safe by Officer Picarello and Sgt. Fritch (B911).

The U.S. Currency totaled \$1298.00 with the following denominations, 10 \$50-dollar bills, 31 \$20 Dollar Bills, 11 \$10-dollar bills, 12 \$5-dollar bills, and 8 \$1-dollar bills. The money was secured in the Boston Police Department Money safe at Police Headquarters.
