NARRATIVE

About 11:51pm on Saturday, 08/13/2022, Officers Marchionda and Reynolds in the B021A responded to a radio call for a Shot Spotter Activation (1 Round) in the area of 77 Burrell St, Roxbury.

While responding officers were notified by operations of a person shot in that area. Also responding to assist were members of the Youth Violence Task Force, B902 (Sgt. Gero), B103A (Kimayo/Patterson), B412A (Marcel), and TE517 (Warren).

Upon arrival, officers observed a male, later identified as [REDACTED] lying on his back suffering from an apparent gunshot wound to the chest at the intersection of Burrell St and Batchelder St. During this time Boston EMS was also on scene providing life saving efforts to the victim. At this time the victim was transported to Boston Medical Center for further medical treatment. The B412A followed ambulance to Boston Medical Center. Dr. Twomey informed the B412A that the victim was critical yet stable.

While on scene officers canvassed the area for any additional victims, suspects, witnesses, and ballistic evidence. Officers located one (1) spent shell cartridge at the intersection of Burrell St and Batchelder St. Officers also located two small amounts of blood stains.

B-2 Detectives B982 (Sgt. Det. Devito) and B810 (Det. Ramos) responded and processed the scene.

NARRATIVE

As a result of an investigation, Detective Antoine J. Ramos (B810) has identified Devon HAMILTON DOB [REDACTED] (to be referred to as **HAMILTON** aka Suspect) as the suspect who committed the following offenses: ASSAULT TO MURDER +60, ARMED (M.G.L. c. 265 §18(a)); A&B WITH DANGEROUS WEAPON +60- TO WIT: FIREARM (M.G.L. c. 265 §15A(a)); FIREARM, DISCHARGE WITHIN 500 FT OF BLDG (M.G.L. c. 269 §12E); A&B WITH FIREARM (M.G.L. c. 265 § 15E); FIREARM, CARRY WITHOUT LICENSE (M.G.L. c. 269 §10(a)); FIREARM WITHOUT LICENSE, CARRY LOADED (M.G.L. c. 269 §10(a)&(n)); and AMMUNITION WITHOUT FID CARD, POSSESS (M.G.L. c. 269 §10(h)(1)), at **69 Burrell Street, Roxbury MA on August 13, 2022.**

Background and Incident

Taken from an incident report authored by Officer Marchionda (#222061649):

About 11:51pm on Saturday, 08/13/2022, Officers Marchionda and Reynolds in the B021A responded to a radio call for a Shot Spotter Activation (1 Round) in the area of 77 Burrell St, Roxbury.

While responding officers were notified by operations of a person shot in that area. Also responding to assist were members of the Youth Violence Task Force, B902 (Sgt. Gero), B103A (Kimayo/Patterson), B412A (Marcel), and TE517 (Warren).

Upon arrival, officers observed a male, later identified as [REDACTED] lying on his back suffering from an apparent gunshot wound to the chest at the intersection of Burrell St and Batchelder St. During this time Boston EMS was also on scene providing lifesaving efforts to the victim. At this time the victim was transported to Boston Medical Center for further medical treatment. The B412A followed ambulance to Boston Medical Center. Dr. Twomey informed the B412A that the victim was critical yet stable.

While on scene officers canvassed the area for any additional victims, suspects, witnesses, and ballistic evidence. Officers located one (1) spent shell cartridge at the intersection of Burrell St and Batchelder St. Officers also located two small amounts of blood stains.

B-2 Detectives B982 (Sgt. Det. Devito) and B810 (Det. Ramos) responded and processed the scene.

The Investigation

As a result of this report and the continued ongoing investigation into the Person Shot/ShotSpotter Activation incident (#222061649) at 69 Burrell Street, Detective Ramos was assigned to investigate this incident.

The following paragraphs will provide a summation of the events and actions taken by responding Boston Police Officers on the night of this shooting incident as well as a summation of Detective Ramos' investigation. Officers Body Worn Camera (BWC) was reviewed in addition to speaking with on-scene Detectives.

On August 13, 2022, at about 11:51 PM, District B-2 Units responded to 77 Burrell Street for a Person Shot /ShotSpotter incident. On arrival, a black male suffering from a shot wound to the lower left back area was located. The male was located in front of 69 Burrell Street lying on the sidewalk bleeding from his back and stomach area. The victim was lying on the side of his body with his feet on the street. The victim was wearing a red "Tommy Hilfiger" t-shirt and camo pattern cargo shorts and black suede Puma sneakers. The victim was later identified as [REDACTED] with a current age of [REDACTED]

The victim was transported to Boston Medical Center to receive further medical treatment for the injuries sustained from the gun shot wound. Detective Gamble (B832) was deployed to Boston Medical Center Emergency room to collect physical evidence from the victim.

Officers began setting up the crime scene and canvassing the area for evidence related to the Person Shot incident. In the center of Batchelder Street and Burrell Street, Officers located **one .18 millimeter spent shell casings** (Gold in Color) on the street. In addition, a pool of blood was observed where VIEIRA was lying on his side.

During the continued canvas of the crime scene Officers located a second location where blood was located behind MA Reg [REDACTED] which was parked on Batchelder Street.

Detective Ramos (B810) and Sergeant DeVito (B982) arrived on scene to begin the initial investigation into this Person Shot incident. While on scene, Detective Ramos observed locations where video surveillance was setup throughout Burrell Street. The two blood spots were swabbed and the .18mm spent shell casing was recovered by Detective Ramos.

Using HAMILTON's date of birth, social security number, and Massachusetts driver's license, Detective Ramos began reviewing and researching known law enforcement databases, to include but not limited to: Criminal Justice Information Services (CJIS), Board of Probation (BOP), Mark43 (Boston Police Report Writing System) to identify him and his previous documented criminal history. He does not have a license to carry a firearm in the Commonwealth of Massachusetts.

Based on all of the above, Detective Ramos has probable cause to believe that Devon HAMILTON did in fact shoot the victim [REDACTED] on August 13, 2022.
