**NARRATIVE**

About 2:45 AM on Saturday, 10/15/22 Officers Lukas and Scott in the A103A made an onsite arrest of Carl Larson at 134 Salem Street, Boston.

Also responding was A202A (Cassino/Wynn) AG01A (Kennedy) A914A (MacIsaac), A422A (Petruzzello), A421A (Merricks).

While on random patrol on Prince Street, Officers heard yelling coming from the area of Bova's Bakery, 134 Salem Street. Officers approached the intersection where multiple people were yelling. Officers observed a large pane glass window that had been shattered and an individual sitting on the sidewalk bleeding. Multiple people on scene pointed down Salem Street to the suspect, Carl Larson, who was running from the scene. Officers chased the suspect, Larson, down Salem Street onto Noyes Place where he was attempting to climb a fence in an alleyway. Officers gained control of Larson and placed him in handcuffs for further investigation.

Once back on scene, Officer Lukas observed the victim, [REDACTED] to have a serious laceration to his left wrist which was significantly bleeding. Multiple individuals were attempting to stop the bleeding with towels to no avail. Officer Lukas placed his department issued tourniquet on [REDACTED]'s left arm and notified channel 2 dispatch of the time. Officers were made aware that EMS was already dispatched.

While speaking with [REDACTED] and other bystanders, it was reported that [REDACTED] was engaged in a fight Larson at which point he was thrown through the large glass window causing it to break. As a result of going through the window, [REDACTED] suffered the laceration to his left wrist.

Another victim, [REDACTED], stated that he and [REDACTED] were walking out of Bova's Bakery at which point words were exchanged with Larson. [REDACTED] stated that they did not know Larson. [REDACTED] stated that during the verbal altercation, Larson began to swing his fists, striking [REDACTED] multiple times in the head. [REDACTED] stated that Larson fled on foot just prior to Officer's arrival on scene.

Boston EMS 1A92(Naughton/Hines) arrived on scene and immediately brought [REDACTED] into the ambulance. [REDACTED] was also brought into the ambulance to be evaluated. Once in the ambulance, [REDACTED] stated that he had loss of feeling in portions of his left hand and difficulty moving his fingers. Due to the injury which was later described as an arterial bleed, [REDACTED] was transported to Brigham and Women's Hospital due to the availability of a hand specialist. [REDACTED] was also transported for evaluation.

Larson was charged with **MGL c265 s13A Aggravated Assault and Battery, MGL c265 s13A Assault and Battery, and MGL c266 s127 Malicious Destruction of Property.**

Larson was transported to the A1 District Station by the A202A (Cassino/Wynn) where he was booked without incident. Officers assisted Bova's Bakery in acquiring a company to secure the window until it could be replaced.
