NARRATIVE

About 3:15 PM on Tuesday, November 15, 2022, Officer Ostholthoff (A690D) made an on-site warrant arrest with additional charges at 47 Joy Street, Boston.

Detective Whalen (A834), Officers McCullough and Daniels (A102D), Officers Kalinski and Leighton (A202D), and Chapman and Castro (A103D) assisted.

The Officer was patrolling the area around Bowdoin Manner when his attention was drawn to a male subject (standing with an unrecognizable white female) on Bowdoin Street at Derne Street. The male subject matched the description of a suspect (Timothy Campbell DOB [REDACTED]) wanted on multiple warrants (which the Officer confirmed were active at the start of his shift), one of which was in relation to an armed robbery and aggravated assault involving a knife at Macy's in Downtown Crossing on 9/13/22 (I222069426).

The Officer is very familiar with Timothy Campbell's most recent booking photos (accessed via CJIS and AFIS-R) along with his driver's license photo (which Officers Ostholthoff and McCullough regularly keep up on their cruiser's computer screen during their shift).

Officer Ostholthoff is also familiar with Timothy Campbell's girlfriend, [REDACTED], who resides at [REDACTED] (FIOE #FC22004525). Officers Ostholthoff and McCullough spoke most recently with [REDACTED] on 10/20/22 at her apartment inside [REDACTED], at which time she informed Officers he still does frequent both the building and the area.

Timothy Campbell is known to Officers in A1, C11, and B2 to be violent toward police. Campbell has multiple firearm-related convictions, armed assault to kill and home invasion charges, carrying dangerous weapon charges, and multiple resisting arrest/failing to stop (Ch. 90) convictions across his juvenile and adult BOPs.

Officer Ostholthoff approached the male subject and greeted him by saying, "Tim, where you been?" The male subject turned, looked at the Officer, and immediately walked onto Derne St and continued walking toward Temple Street. While the Officer was following him, Campbell was shouting to seemingly nobody that his name was "William," suffered from "mental health problems," and "needed help." The Officer eventually caught up to and stopped Campbell at 50 Temple Street.

Officer Ostholthoff attempted for approximately two minutes to de-escalate Campbell's disruptive, uncooperative behavior and gave him the opportunity to prove that he was "William" and not Timothy Campbell. The male subject refused to cooperate and without warning began to run away on Temple Street toward the State House. The Officer updated Boston Police Operations on Channel Two, and gave chase.

The male subject ran onto Derne Street, took a right on Hancock Street, an immediate left onto an adjoining alley that connected to Joy Street, took a right on Joy Street, and an immediate left onto Smith Ct. When Campbell seemingly realized Smith Ct was a "dead end" alley, he turned, dropped his left shoulder, and attempted to charge through Officer Ostholthoff in an effort to get back to Joy Street, striking him in the chest in the process.

At this point, the Officer managed to bring Campbell to the ground, where a fight ensued. Officer Ostholthoff pinned Campbell to the ground and updated Operations as to his location. With the help of Detective Whalen along with Officers McCullough and Daniels, the male subject was eventually placed in custody.

Officer Ostholthoff suffered minor lacerations on his left hand during the fight on the ground. Campbell did not report any injuries on scene.

At this time, the male subject openly admitted to Officers that he was in fact Timothy Campbell.

Officers Kalinski and Leighton transported Campbell to District A1 for booking.
