**NARRATIVE**

About 6:37PM on Friday, November 18, 2022, Members of the Youth Violence Strike Force consisting of Officers J. O' Brien, S. Muhammad, Tpr B. Caccamo (VK06), C. Stevens, D. Layden, Tpr Alldredge (VK16), M. Conley, N. Bernazzani, S. Butler (VK05), C. Smerz, B. Stallings, P. Lekeditis (VK10), K. Cahill, B. Lyons (VK02), Fullam, Capriles, Parham, Hegerich (VK04), along with YVSF Detectives B. Ball (VK810), D. Medina (VK805), Detective J. Rodrigues (V810), under the direct supervision of Sgt P. Byrne (VK901) and Sgt K. Jones (VK906) executed a search warrant resulting in the arrest of suspect Jonathan Marius and the recovery of a firearm at Temple St/River St, Mattapan.

Based on information gleaned from an active firearm investigation, YVSF Officers became aware that Jonathan Marius may be in possession of an illegal firearm and was residing at 55 Temple St, Mattapan.

On Thursday, November 17, 2022 YVSF Detective B. Ball (VK810) applied for and was granted Dorchester District Court Search Warrant #2207SW331, approved by ADA Caitlin FitzGerald and signed by Clerk Magistrate Anthony

Owens, for the person of Jonathan Marius. A search warrant was also granted for Suspect Marius' residence, 55 Temple Street.

Armed with the aforementioned warrants, YVSF members began conducting surveillance on the target address from numerous locations in Boston Police "Soft cars." Additional YVSF officers were operating unmarked Black Ford Explorer police cruisers with low profile emergency lights affixed to the interior and exterior of the vehicle, the majority of officers were wearing outer ballistic carrier vests with "Boston Police" and "Mass State Police" Gang Unit insignia affixed to the front and rear of their vests and badges prominently displayed on their outermost garments and body worn cameras activated. These additional officers were positioned along several locations outside the perimeter of the target address.

While on surveillance, officers observed the suspect (Marius) wearing a dark colored jacket (with the hood on), a black facemask, and dark colored jeans exit the front of 55 Temple St and began walking up Temple St toward River St in a hurried manner.

Believing the suspect was indeed armed with an illegal firearm, Officers maintained surveillance and postured to stop Marius to execute the search warrant on his person. VK10 (Smerz, Stallings, Lekeditis) exited their unmarked cruiser, announced their presence and attempted to stop Marius. Marius, recognized the unmarked cruiser, grabbed his waistband, and immediately fled into oncoming traffic to evade the officers. After a brief foot pursuit, the officers grabbed Marius, who began fighting the officers for control of the gun. The officers shouted numerous verbal warnings to "let go of the gun." Marius continued to grip the handle of the firearm, refusing the officer's commands. Officer C. Hegerich delivered several empty hand strikes to Marius' upper body in an attempt to gain Marius' compliance. After a brief, but violent struggle, the officers were able to secure Marius into handcuffs.

Marius was read his Miranda Warning from a card by Officer Muhammad in the presence of Tpr Caccamo which Marius acknowledged and demanded Marius' MA license to carry, which he stated "no."

The officers recovered a black SCCY CPX-2 9mm Firearm (SN:947084) which fell from Marius' rear waistband. The recovered firearm had (1) 9mm live cartridge in the chamber, and (10) 9mm live cartridges in the magazine. The firearm and its accessories were photographed and processed by Det. B. Ball (VK810) and Det. D. Medina (VK805). Each item was logged and secured in the District B-3 gun safe.

Additionally, a black iPhone with a cracked screen was seized and logged as evidence.

Marius was transported to District B-3 by Officers Araujo/Turner (C113F) where he was booked and processed by Officers Fullam/Hegerich. Marius sustained a minor cut to his lip area during the arrest and declined to be seen by EMS. A Visible Injury Report will be completed.

It should be noted that following the arrest of Marius, a search warrant was executed at Marius' home 55 Temple St, Mattapan. (Refer to I222089602)

Jonathan Marius will be charged in Dorchester District Court with the following:
