**NARRATIVE**

About 12:34 am, Wednesday, December 28, 2022, Officer Kennedy (H425A) & Officer Albino (H441A), conducted a motor vehicle stop at Bowdoin St and Geneva Ave, which lead to a firearm arrest.

While on patrol in a marked Boston Police cruiser on Bowdoin St, traveling towards Geneva Ave from the area of Topliff St, Officer Kennedy observed Ma Reg [REDACTED] (Red 4 door Hyundai).

Officer Kennedy conduct a CJIS inquiry of the of the vehicle. The license plate came by to a Red 2001 Honda Accord. The plate registration status was revoked due to the insurance.

While approaching the red-light Geneva Ave on Bowdoin St, Officer Kennedy activated his emergency lights and siren to conduct a traffic stop, with the assistance of the H441A (P.O. Albino) who was directly behind Officer Kennedy in another marked Boston Police cruiser.

While directly behind the Hyundai with lights and sirens activated, the vehicle stood stationary at the red light for a small amount of time, then proceeded through the red light (Bowdoin St & Geneva Ave) at a slow speed. As the vehicle went through the intersection traveling a small distance from 130 Bowdoin St to 118 Bowdoin St, the vehicle stopped in front of 118 Bowdoin St.

Officer Kennedy approached the driver window and spoke with the operator, later identified as Gequann Perry, Perry provided a Mass driver’s license. Officer Albino approached the vehicle from the passenger side. Officer Kennedy asked Perry about the failing to stop immediately, Perry stated he did not know what was happening. The passenger later identified as Cynthia Owens, stated the vehicle belonged to her friend. Owens stated she was unable to locate the registration.

Officer Kennedy conducted a CJIS inquiry on Perry, CJIS showed Perry’s license was suspended since December 20, 2022. CJIS also showed that Perry has multiple prior firearm charger on his criminal history. While conducting the CJIS inquiry from the cruiser, Officer Kennedy and Officer Albino observed Perry and Owens facing the center console /armrest, head facing down, and their arms could be seen moving. Officer Kennedy and Albino returned to the vehicle. Officer Kennedy issued an exited order to Perry and conducted a pat frisk of Perry. Perry was told to standby with Officer Albino on the sidewalk.

Officer Kennedy asked Owens if she had an active driver’s license, to which she stated her license was suspended. Officer Kennedy issued an exited order to Owens and told Owens to standby on the sidewalk.

Officer Kennedy conducted a pat frisk of the immediate area, where Officers observed both parties to be focus on reaching towards. While opening the center console, Officer Kennedy immediately observed what appeared to be a black firearm (SMITH & WESSON Bodyguard) with the magazine pointing up, the slide on the bottom of the console and the barrel facing the front of the vehicle. Officer Kennedy went to move the firearm and the magazine was ejected from the grip. Officer Kennedy observed the magazine to have live rounds.

Officer Kennedy left the firearm concealed within the armrest, in the empty vehicle. Officer Kennedy and Officer Albino then placed Perry into handcuffs. Perry appeared to be confused. Officer Kennedy placed Perry into a cruiser with his hands behind his back. Officer Albino placed Owens into handcuffs.

Additional C-11 units, V933 (Sgt Det. Champagne / C-11 Patrol Supervisor) H103 (P.O. Beshay & Donlon), H436A (P.O. D. Jones), H435A (P.O. Khalid), responded and assisted.

Officer Kennedy observed Perry had moved his hands from his back to his front. Officer Donlon and Officer Beshay assisted with another pat frisk of Perry. During the second pat frisk, Officers were able to see an ankle monitor on Perry.

Perry was then told he was placed under arrest and Officer Donlon read Perry his Miranda Warning rights from a card. Officer Kennedy demanded to see Perry’s LTC License to carry or FID Card. Perry shook his head and said no to both questions. Officer Donlon and Officer Beshay transported Perry to District C-11. Perry was charged with the following offenses.

Officer Jones (H436A) responded and pat frisked Owens. Officer Kennedy read Owens read her Miranda Warning rights. After explaining what was a License to Carry, Owens said she did not have an LTC. Under the direction of Sergeant Det. Champagne, Owens was released and summonsed into court for the following charges,

Sergeant Det. Champagne (V933) responded and photographed the vehicle, firearm and scene.

A CJIS inquiry of the VIN ( [REDACTED] /2012 Hyundai ELANTRA) did not show any result, meaning the vehicle is not registered in the state of Massachusetts.

Peter's towing responded to the scene and took custody of the vehicle (tow slip #0885). Towed Line Notified (Prioleau). The plates were removed from the vehicle and turned over to the C-11 Auto Room.

The firearm was transported to district C-11 by Officer Kennedy. The firearm was logged into the Seize Firearm book, book 2, Page 63 and placed into the C-11 safe. The firearm was loaded with 1 live round (Horandy .380) in the chamber and 7 live rounds (PMG .380) in the magazine.
