NARRATIVE

On January 21, 2023, Members of the Youth Violence Strike Force (YVSF), consisting of Officer's J. O'Brien/Medrano (VK06), J. Sanchez (VK16), R. Schain/Lt A. Lopez/A. Gunther (VK23), N. Litterio/P. Curtain (VK15), R. Foley/P. Sheehan (VK03), YVSF Detectives D. Medina (VK805), B. Ball (VK810) along with the B-3 Anti-Crime Unit, B. Harrington/S. Barker (CK01D), B-3 Detectives, Sgt Det. J. Burrows, Lt Det. J. Fitzgerald (CA81), under the direct supervision of Sgt. P. Byrne (VK901) and Lt. M. Assad (VKA1) conducted an investigation resulting in a warrant arrest of suspect Jonathan Velasquez and the recovery of a firearm and firearm accessories at 2030 Columbus Ave, #2.

Members of the YVSF were aware that the target of the investigation, Jonathan Velasquez (DOB [REDACTED]) had an active straight warrant issued out of Dorchester District Court, Docket# 2307CR000189 for the following:

- MGL: 275:2 Threats to commit a crime (Refer to: I232001596)

Based on the aforementioned warrant, Members of the YVSF Detective D. Medina (VK805), and J. O'Brien (VK06) began conducting surveillance on the target location (2030 Columbus Ave, #2) from several locations around the target address in Boston Police "Soft Cars". Det. Medina observed the target of the investigation exit the front basement door of the aforementioned address and enter a waiting vehicle (RI registration [REDACTED]: 2019 Beige Honda CR-V). Officer O'Brien confirmed the suspect (Velasquez) was wearing a black hoodie and black pants with a red back and entered the right rear passenger seat of the waiting CR-V.

The vehicle then made a U-turn on Columbus Ave and proceeded toward Seaver St. Det Medina followed the vehicle and radioed his observations to the rest of the members of the YVSF who operating black Ford unmarked Boston Police cruisers positioned throughout several locations on the exterior perimeter of the target address. Additionally, the officers were wearing plain clothes with outer ballistic vests with "Boston Police" identifier panels affixed to the front and rear and badges prominently displayed on their outer most garments.

Officer's Medrano (VK6) and Sanchez (VK16) along with Lt Asaad (VKA1) and Officer's Harrington/Barker (CK01D) activated their emergency lights and sirens and conducted a stop of the vehicle at Seaver St/Harold St.

Officers Medrano/Sanchez removed the suspect Velasquez where he was placed into custody without incident. During a pat-frisk of Velasquez' person, Officer's Medrano and Harrington felt what they immediately recognized to be the frame of a gun inside the suspects front waistband area. Officer Harrington alerted the other officers on scene to the presence of a gun and removed a black Glock 19 with an extended magazine from the suspects front waistband area. The firearm, accessories, and backpack were transported by CK01D (Harrington/Barker) to YVSF Office and handed to Det. Medina.

Officer Medrano read suspect Velasquez his Miranda Warning from a card which he stated he understood and demanded his MA license to carry which he stated he didn't have one.

B103D (Pereyra/Crespo) Transported Velasquez to District B-2 where he was booked and processed by Booking Officer Figuereo.

The firearm:

The firearm was determined to be a black Glock 19 Gen 4 with a laser sight. SN: BETF992 with (1) live 9mm cartridge in the chamber, and (32) live 9mm cartridges in the magazine. The firearm and accessories were photographed, fumed, and processed by Det. Medina. The red and silver Nike backpack was processed and logged into evidence by Det. Medina.

Following the arrest of Velasquez, YVSF Officers along with YVSF Detectives Ball (VK810), Medina (VK805), Lt Asaad (VKA1), and Lt Det Fitzgerald (CA81) proceeded to the target address (2030 Columbus Ave, #2) and spoke with the foster mother, [REDACTED]. [REDACTED] signed a Boston Police Consent Search form for the bedroom of Jonathan Velasquez which was captured on Body Worn Camera by YVSF Officer Schain.

Officers executed the consent search on the bedroom of Jonathan Velasquez and recovered the following: (Refer to I232005461)

1. KCI 50 round capacity drum magazine
2. 9mm 31 rnd extended magazine with (25 live 9mm cartridges)
3. Silver Smith & Wesson .40 caliber magazine with (6 live .40 cal cartridges)

4. Blazer 9mm ammo box with (1) live 9mm cartridges)

Jonathan Velasquez will be charged in Roxbury District Court with the following:

MGL:

- 1. 269:10a Unlawful possession of firearm
- 2. 269:10h Possession ammunition without an FID card
- 3. 269:10n Carrying firearm while loaded
- 4. 269:10m Possession of large capacity feeding device

Body worn cameras were activated for this incident.
