NARRATIVE

About 10:15PM on Friday, October 7, 2022, Officer Coppinger while assigned to the front desk at District 3 took a walk-in report for an Armed Robbery.

The officer spoke with the victim ([REDACTED] DOB: [REDACTED]) who stated he was just robbed at gun point in the area of Almont Park. [REDACTED] stated he had a scheduled video shoot for tonight with suspect #1 (Pahelyous Sebastian). [REDACTED] stated he spoke with Sebastian and they agreed to meet at Almont Park prior to the video shoot. [REDACTED] stated he arrived at Almont Park around 9:52PM where he was met by Sebastian who appeared to be nervous. Sebastian began telling the victim "I have beef here" repeatedly. [REDACTED] stated both parties began walking up Almont Street towards a dark hill and eventually made their way behind a large brick building. [REDACTED] stated Sebastian opened the door and appeared to be calling the other parties involved in the video shoot. [REDACTED] stated at this point he began to feel skeptical of the situation and tried to walk away to which Sebastian told him to stay close. [REDACTED] stated Suspect #2 (a light skin Hispanic male standing about 5'6" wearing black hat, black

sweatshirt, black pants) appeared from behind the corner of the building and brandished a black firearm at him and demanded he drop his black bag containing a Sony A73 camera (valued at \$2500), camera light (valued at \$89), and a black bag (valued at \$10). Baptiste stated he dropped the bag and immediately ran away.

The officer broadcast the following description over Boston Police Channel 3. Suspect #1 is described as tall, skinny, black male with short dreadlocks, wearing a grey sweatshirt, and blue jeans. Suspect #2 is described as a light skin Hispanic male wearing a black hat, black sweatshirt, and black pants. Suspect #2 brandished a black firearm.

The C802 (Det. Delascio) and C807 (Det. Rooney) arrived and spoke with the victim.

About 1:00am on Saturday, 10/08/22, Officer White, while assigned to the front desk of District B-3 located at 1165 Blue Hill Ave, Dorchester took a walk-in report for threats to do bodily harm.

[REDACTED] DOB ([REDACTED]) stated that Pahelyous Sebastian started sending him messages on Snap Chat, in regard to meeting somewhere so that Pahelyous can give back the camera he stole from [REDACTED], earlier that night (10/07/22). [REDACTED] stated that he texted back, agreeing to meet up. When [REDACTED] took longer than expected, Pahelyous began asking for Geordany for his home address and began sending threatening messages like: ("make sure u got a gun cuz it finna be some blood").

[REDACTED] stated that he never met up with Pahelyous and was advised to stop all contact moving forward.

Pahelyous snap chat tag is XSkinnyboi.

NARRATIVE

This is a supplement to original BPD report #222077520. The purpose of this supplemental report is to assist in terms of securing an application for an arrest warrant out of Boston Municipal Court (Dorchester).

On Friday, 10/7/22 - the victim [REDACTED] - [REDACTED]) walked into the BPD Area B-3 police station to make a report about having been just robbed at gunpoint. [REDACTED] and the suspect (Phalonyous SEBASTIAN - [REDACTED]) are acquaintances through the creation/filming of music videos. [REDACTED] professed to becoming a locally well-known video director, whose services appear to be quite in demand. To this end, [REDACTED] purchased for himself a Sony A73 video camera equipped with a camera light. These items were stored/carried in a black bag.

Mr. Sebastian (social media profile Xskinnyboi) reached out to [REDACTED] to arrange booking him for a rap video shoot. After a short negotiation regarding the cost and location, [REDACTED] agreed to meet with Mr. Sebastian on 10/7/22 (at around 9:30pm) in the area of Almont Park. [REDACTED] stated that when Mr. Sebastian arrived, he appeared extremely nervous and kept repeating that he 'had beef here.' Mr. Sebastian suggested that they walk up the street a bit, where they eventually ended up behind a large building (believed to be the area of 85 Tennis Road). At this point [REDACTED] noticed that Mr. Sebastian began sending messages on his phone. [REDACTED] thought this was odd and began feeling very skeptical of the situation. [REDACTED] tried to keep some distance between himself and [REDACTED] and the entrance to the building (even at one point turning to try and walk away), but Mr. Sebastian ordered him to stay close.

At this point, a second suspect (Hispanic male, light complexion, 5'6", black hat, black sweatshirt, black pants) appeared from behind the corner of the building and brandished a black firearm. This second suspect immediately demanded that [REDACTED] drop his camera bag, which he did - and then ran away (to the B-3 station).

On 10/7/22, Detective Rooney met with [REDACTED] in the Area B-3 lobby while he was making his report. [REDACTED] stated that he was set up by Mr. Sebastian (Mr. Sebastian initially tried to pretend like he was a victim too, but did not end up running away when the suspect with the gun presented himself and appeared to know him - as when [REDACTED] looked over his shoulder to see if anyone was giving chase, he observed Mr. Sebastian standing with the second suspect). [REDACTED] told Detective Rooney that his cellular phone was dead, but that if he could charge it for a moment, he could provide Mr. Sebastian's photo/social media pages/and name based on the interactions they had leading up to the incident in question. Detective Rooney provided [REDACTED] with a phone charger, and he was able to provide helpful information for the report/investigation.

On Saturday, 10/8/22 - [REDACTED] returned to the Area B-3 lobby to make a supplemental report. Mr. Sebastian had initially been sending messages about possibly returning [REDACTED] camera, but then began asking for his home address. At this point the messages become threatening ("make sure u got a gun cuz it finna be some blood"). Mr. Sebastian began leaving threatening voice texts (and sending additional messages - "i'm still in boston" - "i'm fucking kill u"). The voice text [REDACTED] played for Detective Rooney (which was saved and added to the case file) is about forty (40) seconds long - the entirety of the message is laced with violent profanity and threats to kill [REDACTED] (including a claim to know his home address).

On Sunday, 10/9/22 - [REDACTED] returned to the Area B-3 police station and participated in a photo array and short interview. The C809 (Det. Kane) acted as the blind administrator, and [REDACTED] was able to positively identify Phalonyous Sebastian as the person who set him up and has since been making violent threats towards him.

Based on the original report, supplemental report, [REDACTED] statements, the phone messages, and the positive photo array identification - Detective Rooney will be seeking an arrest warrant for Phalonyous Sebastian out of BMC Dorchester for the following charges:

Armed Robbery (MGL c265s17d) and Intimidation of a Witness (MGL c268s13b).
