Upon arrival, Officers observed a black male wearing a black sweater and blue tactical pants restraining a black female wearing a black jacket with blue jeans outside Walgreens. Officers placed handcuffs on the black female and seized a gray metal skinny rod believed to be an antenna. A CJIS inquiry revealed the suspect to be **Raquel Ayala** (██████████). Officers confirmed that a knife was never used during the altercation. The black male, ██████████ (██████████), identified himself as security for the premise.

██████████ stated he observed her walking on Aisle 5 and put two bottles of detergent inside her bag. ██████████ then confronted Ayala about the items. At this point, ██████████ stated that Ayala armed herself with a gray object believed to be an antenna and left the store. ██████████ then restrained her until the police were called. While restraining Ayala, ██████████ stated that she spat on him and kicked him. ██████████ declined medical attention.

Ms. Ayala stated that ██████████ had been following her since entering the store and did not allow her the opportunity to pay for the items. While being restrained, Ms. Ayala stated she sustained injuries to her ribs. Boston EMS A20 (Decarlo, Santangelo) responded and transported Ms. Ayala to the hospital for further evaluation.

B2 Patrol Supervisor B910(Onishuk) was notified. Officers verbally trespassed on the premise based on the events that transpired.

NARRATIVE

This is a supplemental report, in which after an investigation was conducted, the two suspects were identified as Raquel Ayala () and Christopher Thomas, . Detective Wyman will be seeking an arrest warrant from Roxbury Court for Ayala for: Armed Robbery, assault with a dangerous weapon, assault and battery (spit and hands), destruction of property. Detective Wyman will also be seeking an arrest for Thomas for: Assault and battery with a dangerous weapon - shod foot, and two counts destruction of property.

The following a summary of the original incident.

About 08:20AM on Friday 10/21/2022, Officer Joseph and Baez assigned to the B201D responded to a radio call for a Fight at Walgreens, 2275 Washington Street, Roxbury. Upon arrival, Officers observed a black male wearing a black sweater and blue tactical pants restraining a black female wearing a black jacket with blue jeans outside Walgreens. Officers placed handcuffs on the black female and seized a gray metal skinny rod believed to be an antenna. A CJS inquiry revealed the suspect to be Raquel Ayala (). The black male, (), identified himself as security for the premise. stated he observed her walking on Aisle 5 and put two bottles of detergent inside her bag. then confronted Ayala about the items. At this point, stated that Ayala armed herself with a gray object believed to be an antenna and left the store. then restrained her until the police were called. While restraining Ayala, stated that she spat on him and kicked him. declined medical attention. While being restrained, Ayala stated she sustained injuries to her ribs. Boston EMS responded and transported Ms. Ayala to the hospital for further evaluation.

As a brief background, the Walgreens located at 2275 Washington Street has had an ongoing issue with shoplifters. In 2022 alone approximately 42 reports have been taken from this location for a variety of offenses most of which are shoplifting. When Detective Wyman responded to the location to meet with the victim, he observed numerous signs posted throughout the store stating the store will be closing permanently on November 8, 2022. Detective Wyman was informed that the corporate office decided to close the store due to all the issues there over the years. This occurs, despite hiring a private security officer to be in the store, and numerous arrests/summons for shoplifting made by the Boston Police Department. The closing of this store due to these issues, hinders the surrounding community, especially a number of elderly housing services that utilize the central location to their residences.

As part of the investigation Detective Wyman viewed body camera footage from responding officers in which the female suspect was positively identified as Ayala. As previously mentioned, she was transported to the hospital due to injuries sustained.

Detective Wyman responded to 2275 Washington Street and met with . stated he is familiar with the Ayala as being a frequent shoplifter. When he observed her entering the store, he watched her movements. also noted that she was with a male companion that she is frequently with. stated that he observed Ayala putting multiple items in her bag. Additionally, items were retrieved from her bag and were returned to the store.

██████████ stated that Ayala then attempted to walk out of the store without ever going to the register to make an effort to pay for the items. ██████████ stated he got between her and the door and attempted to stop her and retrieve the items. At that point a scuffle ensued, and the male party that Ayala was with also joined in. ██████████ stated that Ayala spit at him and that she then armed herself with a long object believed to be an antenna and held it up at him. ██████████ stated he was eventually able to restrain Ayala and locked the doors, so that she could not exit. At this point the male suspect was outside of the store and when the doors were locked, he threw a rock at the door causing a large crack in the door. Detective Wyman observed the severe crack in the door. Additionally, Detective Wyman observed that the stores shoplifting detectors that are located at the stores exit were knocked over. ██████████ stated that this occurred during the fight.

Detective Wyman was able to recover video from the incident. The camera was trained on the entrance/exit. It is observed that Ayala is attempting to exit the location, with the male suspect standing next to her. ██████████ then blocks her path and attempts to grab her bag. Ayala pulls the bag back and begins to push ██████████. ██████████ then grabs her and the male suspect begins to push ██████████, and then kicks ██████████ with a shod foot. As the three parties are involved in a scuffle they fall into the shoplifting detector and it is knocked over. Both parties continue to wrestle with ██████████ and ██████████ is able to eventually retrieve a bottle of detergent that fell from Ayala's bag. At this point a second altercation occurs out of the range of the camera and ██████████ stated that was when she armed herself with antenna and held it up to him in a threatening manner.

The male party then gathers items off the floor and walks out of the store, while Ayala is on the floor also picking up items. At that point ██████████ was able to lock the outer doors to lock Ayala in until the police arrived, and lock the male party out. ██████████ stated that was when the male threw the rock at the door. The male then left on a city blue bike towards Ruggles Street.

On Thursday, October 21, 2022 Detective Wyman sent out an email to the BRIC and the officers in district two, with images of the male party as an attempt to identify him.

Within six minutes of sending the email, Officer Kerrigan, B-2, responded to only Detective Wyman on the email and stated he knew the male party to be Christopher Thomas, ██████████. Officer Kerrigan stated he has had numerous incidents with Thomas and Ayala, including but not limited to, I222021113 and FIO 21338336. Officer Kerrigan knows them to be a couple, and that they frequently use city blue bikes as their mode of transportation.

Detective Wyman also received separate emails from Officer's Bertocchi and Walsh who also identified Christopher Thomas being the male suspect.

Detective Wyman was able to view a recent booking photograph of Thomas, from August 2022, and observed that he had a striking resemblance, in facial features and hair style, to the person in the video.

Due to Ayala being identified on-scene and having no fixed address, Detective Wyman will seek a warrant from Roxbury District Court for the following offenses: Armed Robbery (265;17), Assault with a dangerous weapon, to wit antenna (265;15b), Destruction of Property (266;127c) - for the security device, Assault and Battery (265;13a) - spit and hands.

Christopher Thomas currently has an active default warrant out of Roxbury District Court for assault with a dangerous weapon, issued on October 18, 2022. Detective Wyman will be seeking an additional arrest warrant out of Roxbury District Court for Thomas due to having no fixed address and already having a default warrant. Thomas to be charged with: Destruction of Property (266;127c) - for the security device, Destruction of Property (266;127c) - for the window, Assault and Battery with a dangerous weapon, shod foot (265;15a).

About 4:44 PM, on Thursday 12/01/22, Officers Figueroa and Gonzalez in the B102F assisted by Pires/Green in the B431F, responded to a radio call for a [REDACTED] at 76 Lawrence Ave, Dorchester.

Upon arrival, Officers met with the reporting party/victim [REDACTED] (DOB: [REDACTED]) at the above location, who stated that her sister Raquel AYALA (DOB: [REDACTED]), had a warrant. [REDACTED] also stated to the officers that her sister has a [REDACTED] and had Probate and Family Court Papers (DOC: [REDACTED]) to hand to her sister Raquel AYALA. [REDACTED] stated that she does have an active default warrant (DOC: [REDACTED]) out of Roxbury Court. [REDACTED] stated that she has been trying to help her sister Raquel AYALA and her child ([REDACTED]) who have been homeless for about two years, but could not do it anymore. [REDACTED] stated that she went to Probate and Family Court to gain guardianship for Raquel AYALA's daughter, [REDACTED].

It should be noted that at the above location, the daughter [REDACTED] was not present.

Officers did a CJIS query on both parties [REDACTED] came back negative with any warrants or restraining orders.

Raquel AYALA came back with an active default warrant (DOC: 2202CR002095) out of Roxbury Court by the Honorable Kevin LYLES.
