**NARRATIVE**

About 7:48AM on Thursday 3/16/23, Officer Alleyne while in the L412D unit responded to a Radio Call for a Breaking and Entering Report at 601 Cummins Highway., Hyde Park (Reggs Auto Service).

Upon arrival to the above location, Officer Alleyne spoke with an employee of the auto shop, [REDACTED], who stated that according to the video cameras, someone came stole a 2011 Gray Subaru without the registration plates on it out of the lot and drove it into the fence to exit the lot. [REDACTED] stated that the suspect broke the glass door to the auto shop, went in, and stole the keys to the Subaru. Officer Alleyne observed a broken fence, which was partially on the ground and observed the door to the auto shop to be completely broken and shattered. It should be noted that the Gray Subaru sustained damages during this incident due to the vehicle being driven into the fence. [REDACTED] stated that the suspect may have hopped over the fence to enter the lot.

### NARRATIVE

About 10:35 AM on Thursday March 16, 2023 Officer Politsopoulos and Officer Burgos while assigned to the L101D on sighted and effected an arrest for a stolen motor vehicle at 745 River Street, Hyde Park.

See 1.1 Report: (Offense/Incident:VANDALISM I#232020015) Officers were on patrol in the area of River Street at Thorn street specifically looking for a recent stolen motor vehicle out of 601 Cummins Highway.

Earlier in the morning District 18 detectives documented the scene at 601 Cummins Highway where a breaking and entering took place and a gray Suburu Outback was stolen. Detectives were able to review security camera footage and immediatelly recognized the suspect (Jonathan Osorio) due to a seperate stolen motor vehicle incident where the suspect was arrested. The suspect (Jonathan Osorio) had a distinct cast on his right wrist/forearm due to a prior injury, that cast/injury was documented due to his prior arrest/booking. District 18 detectives (L818-Sheesley & L802-Harrington) informed officers the suspect resided at 20 Thorn Street.

About 10:35 AM officers were traveling on River Street towards Cleary Square. Officers observed a gray Suburu Outback performing a 3 point turn in the middle of the road. Officers observed the vehicle to have MA REG: [REDACTED] attached to it and noticed what appeared to be blood dripping down the license. a CJIS query of MA REG: [REDACTED] revealed the plate is registered as a 2009 gray Volkswagon Passat. While the vehicle also performed the three point turn officers could clearly and positively identify the driver as the suspect Jonathan Osorio.

The Suburu continued its 3 point turn and parked directly outside 745 River Street, Hyde Park. Officers appraoched the vehicle and upon viewing the license plate closer, officers confirmed it was blood dripping down the license plate and blood drops on the the vehicles rear fender. At this point the suspect was not aware of the officers presence. The suspect began to exit the vehicle and observed the officers approaching and immediately looked shocked and alarmed. Officers noticed a slight bend in his knees, almost as if in an athletic stance, he appeared as if he was going to run. Officers immediatelly began to deescalate giving direction to, "stay right there" and to "chill out." Officers repeatedly gave orders to place his hands behind his back which he refused to do. Officers were able to guide the suspect against the hood of the vehicle and a struggle ensued. The suspect refused to place his hands behind his back, at one point the suspect utilized the hood of the car to grab and hang on to so officers could not place handcuffs on. An officer noticed the suspect had such a tight grip on the hood of the vehicle, his knuckles were white. An officer was able to place one handcuff on his left wrist but were unable to place the right handcuff on due to his large cast. The suspect continued to resist despite having one handcuff on. Due to the suspect (Jonathan Osorio) continuing to resist and attempting to flee, he was taken to the ground. While being taken to the ground, one officer was holding the suspects left arm, and the other was holding his right arm. Due to that, when the suspect was taken down, he sustained injuries to his chin, and left facial area. While on the ground the suspect (Jonathan Osorio) made multiple threats towards the officer stating, "fuck you nigga, I wish I could punch you in your face."

During this altercation officers noticed a front seat passenger (Alvin Mojica) who had a fanny pack strapped across his chest, was moving about the vehicle, and at one point during the struggle attempted to exit the vehicle. Officers gave verbal commands for the passenger to sit still and keep his hands visible.

Officers requested more officers to the scene at 745 River Street. The L412D (Alleyne), L421D (Gorman), L411D (Mendez), L202D (Garcia/Webb), L980 (Sgt. Det. Krause), L802 (Det. Harrington), L818 (Det. Sheesley), R7881 (Gigliello), and R8024 (Roberts) arrived on scene to assist.

Officers removed the passenger (Alvin Mojica) from the vehicle, placed him in handcuffs and pat frisked him for weapons. Inside the fanny pack officers located a taser/stun gun. Officers demanded his License To Carry (LTC) a firearm, he stated he did not have one.

The suspect (Jonathan Osorio) was finally placed in handcuffs utilizing one leg restraint to cuff his cast. Both parties were transported back to District 18 for booking.

Boston EMS Ambulance A18 (Doyle/O'Brien) was requested and arrived at District 18 to treat the suspects minor wounds

While performing a a motor vehicle inventory (FORM2012) officers located a screwdriver which had blood on it and a large knife in the passenger side door, and an open bottle of beer in the center console cup holder.

The driver/suspect (Jonathan Osorio) of the motor vehicle was issued Massachusetts Uniform Citations T3237042, T3237043, and T3237045. He will be charged in West Roxbury District Court with the following charges:
