NARRATIVE

About 8:25 pm on 03/24/23, Officers de los Santos and Lawton assigned to the F631D and F630D respectively, responded to a radio call for a removal from 25 District Avenue (AMC Movie Theater), Dorchester.

Several C-6 Officers along with the Patrol Supervisor SGT McDonough assisted with the incident.

Officers were informed by South Bay security that AMC required the removal of a belligerent male causing a disturbance. The male was described as a black male with yellow sweatpants.

The Officers arrived and observed four teenage girls with a black male wearing a yellow ballcap, yellow sweatshirt, yellow sweatpants, with a red Pyramid chest bag strapped to the front of his body exiting the AMC movie theater. The male, Freddy Bates stated that he brought [REDACTED] to watch the movie Cocaine Beer. He stated that in the theater, he approached a few females attempting to "holler" at them by expressing his interest. He stated that he was

approached by one of the security guards and asked to stop, but that he did not see an issue with his behavior because it was not inappropriate. Then to demonstrate his actions inside the theater, Freddie turned to Officer de los Santos and looked her up and down and stated "Girl you fine. I like it just like that, damn!" He then turned to Officer Lawton and stated "What's wrong with that?"

Officer de los Santos walked into the theater to speak to the Manager of AMC [REDACTED] stated that Freddy Bates entered AMC and from the start he was noticeably loud and rowdy. He stated that he approached Bates and requested that he quiet down but he continued to be loud. Bates went upstairs and engage in horseplay and loud and obnoxious banter. [REDACTED] stated that bates was so loud that he could still hear him from the first floor.

Officers spoke to armed security guard [REDACTED] who stated that Freddy Bates came to the second floor of AMC and was loudly trying to speak with different women. [REDACTED] stated that he approached Bates several times requesting that he lower his voice as he was being disruptive, but Bates began to yell and curse at him. [REDACTED] requested the assistance of the other security guard, [REDACTED] who was downstairs. [REDACTED] came upstairs and given the continued belligerence of Bates, they requested that [REDACTED] leave the premise.

Officers spoke to armed security guard [REDACTED] who stated that he first observed Bates on the first floor when he was attempting to hit on the female ticket taker. As she refused his advances, Bates told her not to "block her blessings" and stating that he has the "big bag" as he proceeded up the escalator to the second floor. Shortly after, [REDACTED] got called upstairs to assist [REDACTED] who had confronted Bates for continuing to be disruptive. [REDACTED] stated that Bates was screaming at [REDACTED] calling him a "Bitch ass Nigga" and became overly aggressive with [REDACTED]. [REDACTED] stated that they asked Bates to leave the premise.

On scene, Officers worked with both parties to resolve the incident by assisting in the process of issuing a refund, which both parties were amenable to. Officer de los Santos was inside AMC with the manager [REDACTED] and [REDACTED]. Officer Lawton was outside with F. Bates and the other daughters when Bates looked up to the second floor and began yelling [REDACTED] who could not hear him through triple pane glass. Bates stormed into AMC and immediately headed for the escalator skipping steps and ignoring repeated commands by Officers to stop. Officers ran after Bates who ascended the escalator and headed straight for [REDACTED]

Bates headed straight for [REDACTED] and stepped in his face attempting to intimidate him, threatening physical harm, and challenged [REDACTED] to "come outside" to fight. [REDACTED] exhibited extreme restraint while Bates was in his face and did not physically engage with him. Officers immediately got between the two to prevent the verbal incident from escalating. Bates began to walk away and then double backed and lunged at [REDACTED] striking him with a closed fist at which time [REDACTED] defended himself. The two began to fist fight lobing blows at each other's face. As they fought the physical altercation moved onto the moving escalator descending to the first floor. There were several people nearby trying to ascertain what was going on and a small crowd began to form overlooking the escalators. Officers called for additional units to respond.

[REDACTED] and [REDACTED] engaged in punching [REDACTED] in the head as they yelled for [REDACTED] to stop hitting their father. Both Officers attempted to maintain balance on the moving escalator while disengaging [REDACTED] from the fight. Officer de los Santos reached down to check that her body worn camera was activated but got pushed back in the frenzy and force of bodies moving backward as the escalator came to a stop, the camera became detached from the magnet falling out of sight onto the escalator steps. Seizing the opportunity to end the physical altercation, Officer de los Santos stepped between Bates and [REDACTED] demanding that they stop. While both men continued to yell at each other there was no further physical contact as Officers were able to keep the two parties separate. Bates

walked down the steps and was placed into custody by the FK01 (Officers Burke and Fullam). It should be noted that at no time did [REDACTED] engage in any physical altercation with any of Bates [REDACTED] despite them punching him several times.

Officer Lawton was informed by [REDACTED] that his holster containing his firearm had dropped and he thought [REDACTED] took it. Officer Lawton immediately began searching the escalator for the firearm and observed [REDACTED] wearing a jacket while carrying a balled-up jacket in her hand. [REDACTED] took off running down the opposite escalator the wrong way. Officer Lawton attempted to stop her but she ran outside. Officer Lawton informed officer Fullam that the suspect ([REDACTED]) may have be in possession of a firearm. Officer Fullam stopped [REDACTED] outside on the public sidewalk and observed her to be holding a black jacket tight to her chest. Officer Fullam controlled [REDACTED] hands and could feel a heavy object in [REDACTED] left hand under the black jacket. After a brief struggle, [REDACTED] dropped the jacket and the item and was placed into handcuffs by Officers Fullam and Sheehan. Officer J. McCarthy picked up the jacket and confirmed the item that had been in [REDACTED] hand to be a firearm. Officers were able to confirm the firearm was the same that [REDACTED] had reported stolen. [REDACTED] was placed under arrest and transported by the F201F (Fitzgerald and Sheehan) to Boston Police District 6 where she was booked.

Officer Burke (FK01F) searched Freddie Bates prior to placing him into a department motor vehicle. Officer Burke felt a small hard metal object that was tucked into the front of a back brace that was wrapped around the waist of Mr. Bates. Officer Burke removed the object and realized it to be a firearm. Further investigation revealed that the firearm was a Hopkins and Allen (22 Caliber). The firearm was loaded with 5 live 22 cartridges. Officers demanded Bates license to carry and it was confirmed that he did not have one. Officer Burke read Bates his Miranda Rights. Freddie Bates was placed under arrest and transported by the F431F (Hamilton) and F499F (McCarthy) to Boston Police District 4 where he was booked.

Officer de los Santos retrieved her body worn camera from the escalator steps and activated it.

Officer de los Santos told [REDACTED] to remain upstairs to avoid any further incidents. [REDACTED] observing [REDACTED] outside in handcuffs became irate screaming at [REDACTED] and launched a wad of spit at him, but missed. The Officer, observing the assault advised [REDACTED] to calm down and informed her that her actions were illegal but she ran down the escalator and outside. Outside she began screaming and demanded that Officers not touch her. [REDACTED] was placed under arrest and was transported by the FG02F (Costello and McCarthy) to Boston Police District 6 where she was booked.

Officers demanded [REDACTED] License to Carry, which he provided. Officer's observed [REDACTED] active LTC with License # 13197318A issued 04/01/22 with an expiration date of 02/23/28 issued out of New Bedford.

Having determined that [REDACTED] was in lawful possession of a firearm, that the firearm was in his possession and accidentally dropped as a result of the incident caused by Freddie Bates, and given his awareness and the urgent nature in which [REDACTED] immediately communicated the loss of his firearm, Officers returned the firearm to him.

After the incident, Officers observed minor lacerations on [REDACTED] forehead.

Outside, Officers observed people gathered in the window of neighboring restaurants and a line of vehicles stopped creating traffic on District Avenue. Officers were also made aware that during the commotion, AMC did not allow any customers to enter the movie theater to purchase tickets or attend movie showings and that nearly all business inside the theater came to a halt.

Det. Magoon (F804) and Det. Moriarty (F808) arrived on scene and photographed and recovered the firearm.

[REDACTED] was released by the Booking Officer to the care and custody of her mother [REDACTED].

It should be noted that at some point during the fight the red chest bag that Freddie Bates was wearing became detached from his body. This bag was not recovered by Officers.
