### NARRATIVE

About 4:02 P.M. On Monday, 4/3/23, Officer Murphy, Officer Antonino and Sergeant Fancelli responded to a radio call for a person with a gun at 393 Massachusetts Avenue, Boston.

Also responding was the D912 (Sullivan), D982 (Carroll), D820 (Texiera), D817 (Gauvin), ,D203F (Crowley/McDonough), D101F (Langham/Dauber), D103F (Walsh/Doherty), D631/D633F (Liang/Gately), TE508 (Cooley) and the TG04 (Moquete/Romero).

Northeastern Police Department Officers Hain (Badge #92), Zirpolo (Badge #50), Watkins (Badge #58) and Sergeant Piantedosi (Badge #40) also responded to the scene.

It should be noted that the witness known to the commonwealth was transported back to District 4 to be interviewed by District 4 Detectives.

Officers were then notified by BPD channel 5 that Northeastern Police were in pursuit of a suspect, later identified as Jaicarie Hill-McConaga, that had just discarded a firearm. The D499F (Antonino) was then flagged down by Northeastern Officers stating a male had just ran down St. Botolph Street into Public Alley 820. Officer Antonino in the D499F along with Sergeant Piantedosi (Badge #40) observed the suspect running down the alleyway that connects Public Alley 820 and Public Alley 822. At that point Officers both ordered the suspect to the ground and the suspect stopped running and complied with Officers commands. Officer Murphy assisted by Officer Antonino and Sergeant Fancelli placed the suspect into handcuffs. Officers then placed the suspect into the D103F (Walsh/Doherty) who remained on-scene detaining the suspect.

Officers responded back to 393 Massachusetts Avenue to the firearm recovered by Northeastern Police Department Officers. Officer Murphy was approached by Northeastern Officer Hain (Badge #92) who initially observed the suspect. Northeastern Officer Hain stated that he observed a black male with a black face covering and all black clothing crouching down on New Castle Ct which is the rear parking lot of 395 Massachusetts Avenue. Northeastern Officer Hain stated he observed the possible suspect crawl under a fence that leads to Southwest Corridor at the rear of Massachusetts Ave train station. Northeastern Officer Hain then began to approach the suspect to speak with him. Northeastern Officer Hain observed the suspect to have his hand in his jacket pockets and appeared to be gripping something. Northeastern Officer Hain was in full Northeastern Police Department uniform making him easily identified as a Police Officer. Northeastern Officer Hain stated that he then ordered the suspect to stop and take his hand out of his pocket in order to conduct a pat frisk for weapons due to the nature of the call. Northeastern Officer Hain stated the suspect then took off in full sprint on the South West Corridor towards Massachusetts Avenue. Northeastern Officer Hain stated he then observed the suspect to remove a small black object that resembled the shape of a firearm from his pocket and place it into that planter garden and continue running on Massachusetts Avenue. Northeastern Officer Hain stated that he notified Northeastern operations of the recovery of the firearm and the direction of flight of the suspect. Upon receiving this information Sergeant Fancelli notified the D103F that the suspect could be transported back to D-4 and was now under arrest.

Officer Murphy then spoke with Northeastern Police Department Sergeant Piantedosi who stated that she was notified of the description and flight path of the suspect who had just discarded the firearm. Northeastern Sergeant

Piantedosi stated that she was on St. Botolph Street when she observed the suspect running down Public Alley 820. At that point Northeastern Sergeant Piantedosi, Boston Police Officers Murphy, Antonino and Boston Police Sergeant Fancelli were able to place the suspect in custody.

Officer Murphy placed the suspect in handcuffs. Officer Murphy demanded to see the suspects License to Carry a Firearm in the State of Massachusetts. The suspect responded by shaking his head and stating "I don't have no firearm". Officer Murphy then read the suspect his Miranda Rights from his Boston Police Patrolman's Association squad book that is distributed to all Boston Police Patrolmen. It should be noted at the time of Officers detaining the suspect, he was out of breath, sweating and not wearing any shoes.

The TG04F (Moquete/Romero) responded to the scene and took thermal images of the firearm. The D820 (Texiera) and the D817 (Gauvin) responded to the scene to recover and process the firearm. The TE508 (Cooley) responded to the scene and swept the area for any other discarded items with his K9 partner.

Officers did seize a black balaclava style mask that was on the suspect at the time of arrest. This was part of the description given out by the witness that was provided to responding Officers. This was logged as evidence, written in the property log book (book 4-11 page 20) and placed in the evidence locker for safe keeping.

The firearm recovered was black Ruger LC9s firearm with 1 round in the chamber and 9 rounds in the magazine. The following ammunition was recovered from the firearm

1 "Blazer 9MM Luger" live found in the chamber

4 "Blazer 9MM Luger" live rounds found in the magazine

1 "S&B" 9MM live round found in the magazine

1 "9MM Luger" live round found in the magazine

3 "WCC" 9MM live rounds found in the magazine
