NARRATIVE

About 3:10PM on Wednesday, April 12, 2023, Officers Coppinger and Garvey while assigned to the C202D responded to a radio call for a Person with a Gun at 40 Glenhill Road resulting in the on-site arrest of Carmen Perreira.

Prior to arrival, officers were made of the following notes through Boston Police Operations:

Officers were travelling in marked Boston Police Patrol Wagon #1620 on Lorna Road en route to 40 Glenhill Road. Officers then took a left turn on to Doone Avenue and observed MA REG # [REDACTED] travelling on Doone Avenue towards Lorna Road. Upon seeing the Boston Police Patrol Wagon, the operator ([REDACTED]) of MA REG # [REDACTED] began to reverse away from officers. Officers immediately exited the wagon and demanded that the operator stop the vehicle. While officers were demanding the operator to stop the vehicle, the C112D (Williamson/Parlon) pulled to the rear of MA REG # [REDACTED]. Once the operator stopped the vehicle officers demanded that all occupants exit the vehicle. Officers first removed the rear left passenger (later identified as the suspect Carmen Perreira DOB: [REDACTED]). Officers then removed the operator of the vehicle ([REDACTED]). Officers then observed there to be three children in the vehicle. Officers allowed for all three children to be safely removed from the vehicle. Officers conducted a pat frisk of the operator, the suspect, and the vehicle which yielded negative results.

Simultaneously, numerous officers from District 3 and Patrol Supervisor Lt. Cullen (BA02) responded to 40 Glenhill Road to further investigate.

Officers O'Connor (CK01D) and Ryan (C111D) were greeted by [REDACTED] who stated that the firearm was inside of his residence on Glenhill Road. Officers requested that [REDACTED] go retrieve the bag to which [REDACTED] returned and handed Officer O'Connor the firearm. Officer O'Connor alerted Boston Police Operations over Channel 3 that a firearm had been recovered and requested District 3 detectives to respond.

Officers O'Connor and Ryan were able to speak with Victim #1 ([REDACTED]) who stated they were at 40 Glenhill Road for a memorial service of the suspect's (Carmen Perreira) deceased mother. Victim #1 stated that she was with the suspect (Perreira) in a room far away from the rest of the party to which the suspect began accusing her of having something to do with her mother's death. Victim #1 then stated that the suspect took a firearm out of her backpack and began waving it in her face. Victim #1 stated that victim #2 ([REDACTED]) was also in the room and began to cry due to the events taking place. Victim #1 stated that she was able to safely leave the room in order to alert her husband ([REDACTED]) of the suspect's actions. Victim #1 stated that she went back into the room with her husband to which he immediately gained control of the suspect's body and she was able to take the firearm out of the suspect's hand. Victim #1 stated she then put the firearm into the suspect's backpack. Victim #1 stated that she began yelling to get the firearm out of the house to which [REDACTED] retrieved the backpack and brought it to his residence. Victim #1 stated that at this point the suspect left the residence in MA REG # [REDACTED].

Officers attempted to speak with Victim #2 ([REDACTED]), but she declined to provide information pertaining to what took place.

Both Victim #1 and Victim #2 declined the need for Boston EMS.

Officers off at the intersection of Lorna Road and Doone Avenue were alerted by officers at 40 Glenhill Road that the suspect was described as a female with blonde hair wearing all black with rhinestones. Officers Coppinger and Williamson then placed the suspect into custody.

Officer Cox demanded the suspect's license to carry numerous times to which the suspect stated, "I don't have a license to carry, and I don't have a firearm." Officer Cox then read the suspect her Miranda Warning from a card which he carries on his person. Officer Meaney then again demanded the suspect's license to carry a firearm to which she stated, "I don't have a firearm and I don't have a license to carry."

The C112D transported the suspect back to District 3 for booking in the usual manner.

The children on scene were left in the custody of [REDACTED] and [REDACTED] who are family members of the suspect (Perreira). [REDACTED] and [REDACTED] were released from the scene and left in MA REG # [REDACTED].

Sergeant Detective Moore (C982) arrived to process the scene and take custody of the firearm.

The firearm was determined to be a Smith and Wesson MOD 410 (Serial #TDR0655). The firearm had a 10-round magazine holding no ammunition and no round in the chamber.

A CJIS Inquiry was conducted on the firearm's serial number which revealed a status of "No Records Found."

Carmen Perreira will be charged with the following:

Unlawful Possession of a Firearm – MGL CH. 269 S. 10a

2 Counts of Assault by Means of Dangerous Weapon to wit gun – MGL. CH. 265 S. 15B

51A filed with the Department of Children and Families
