**NARRATIVE**

About 2:53pm on Friday February 17, 2023, Officer Awad (Z429) and Officer Stevens (Z425) of the Boston Housing Police made an onsite firearm arrest at 275 Centre Street, Jamaica Plain. Also assisting was the VK16 & VK6 (Sanchez /Medrano).

The officers were conducting a vertical patrol of 275 Centre Street due to ongoing complaints from management and residents regarding frequent trespassing inside of the hallway. Specifically, these complaints detail ongoing issues with large groups of juveniles inside of the hallway smoking and drinking. There have also been multiple person with a gun calls inside of the Bromley Heath development within the last several months, with suspects described as being juveniles inside of the various hallways of the development.

Officer Stevens and Officer Awad both approached 275 Centre Street from opposite directions, with Officer Awad entering through the front of the building, and Officer Stevens entering through the rear of the building. As Officer

Awad entered the front, he encountered a juvenile known to both Officer Stevens and Officer Awad as [REDACTED] (DOB: [REDACTED]).

This juvenile male is well known to both BHA officers, as the suspect ([REDACTED]) was recently arrested on 11/07/23 (I# 232001648) by the same officers for breaking and entering at 10 Lamartine Extension, Jamaica Plain. Both Officer Stevens (Z425) and Officer Awad (Z429) have also FIO'd the suspect ([REDACTED]) multiple times for trespassing in various buildings in the development. The suspect ([REDACTED]) is known to the officers as living at [REDACTED] and has been found to be loitering in several different buildings throughout the development. The suspect ([REDACTED]) has been informed multiple times in the past that he will be arrested for trespassing if he is found to be trespassing in buildings inside the development in which he does not live.

As Officer Awad approached the suspect ([REDACTED]) in order to detain him for the crime of trespassing, the suspect ([REDACTED]) appeared to be extremely nervous and said "I'm leaving" and attempted to run past the officer. The officer noticed that the suspect ([REDACTED]) had his hand in his pocket and was clutching his waistband through his jacket pocket. Due to this exhibited behavior, the officer attempted to conduct a pat frisk for weapons; however, the suspect ([REDACTED]) ran past the officer and started to run on Bickford Street. At this point the VK16 (Sanchez/Sergio) observed ([REDACTED]) fleeing grabbing on to his upper left side on his waistband. At that time, Officers Sanchez and Medrano began to chase the suspect as they announced, "Boston Police" ([REDACTED]) continued to run from the officers until he ran into the frontend of a parked vehicle causing him to trip and fall on the ground outside the side of 60 Bickford Street. Officer Medrano conducted a pat frisk on the suspect ([REDACTED]) waistband area and felt a hard metallic object consistent with the shape and size of a firearm located on [REDACTED]'s front waist band area. Officer Medrano alerted officer Sanchez of the presence of a firearm and [REDACTED] officer Medrano then removed a small black firearm from the suspect's front waistband.

[REDACTED] was transported to E13 for booking by the Z429 and Z428 (Resil). [REDACTED]'s mother, [REDACTED], was contacted by booking officer Angel Figueroa.
